Announcement of Tentative Motion

2016-04-13-Motion-Cemetery-Plots-Management

I move that during the May 2016 Regular membership Meeting that we vote on the following amendment to our Constitution and By-Laws, after having it published in the next newsletter. At the end of the following paragraph; "Moved that "Exception; donated cemetery plots, and/or subsequent revenue derived from the sale or disposal of them be considered as 'donations' and be accounted for and managed from the donations account, and that proceeds from such donation(s) (should there be any) and subsequent disposal of them be managed by the Executive Committee, and any revenue derived from them be held in the 'donations' account."

Currently our 'Constitution, Article XI, Section 6' reads: "Real Property Sales. In the event the Post sells any of its real property, the proceeds from such sale shall be placed in a Trust to insure that the corpus of said Trust shall be kept intact. These monies shall be known as the American Legion Post 177 Trust Fund. The Board of Directors of said Post shall conservatively invest and reinvest the Trust Fund at the maximum rate of return consistent with the safety of the corpus of the Trust, and in accordance with the laws of the Commonwealth of Virginia.

Motion to Amend Post Constitution regarding Quorums

Fairfax American Legion Post 177 Constitution is silent on a specific quorum for the Corporate Board for meetings of or voting requirements on initiatives or motions.

Robert's Rules of Order, 11th Edition, Chapter XIV; §49. BOARDS; Ex-Officio Board Members; Line 35; states that "Frequently boards include ex-officio members-that is persons who are members of the board by virtue of an office or committee chairmanship held in the society or some allied group... If the ex-officio member is not under the authority of the society, he has all of the privileges of the board membership, including the right to make motions and to vote... The latter class of ex-officio board member, who has no obligation to participate, should not be counted in determining the number required for a quorum or whether a quorum is present at a meeting." 'Society' as used here means the Board of Directors.

The CONSTITUTION of Fairfax Post No. 177, Department of Virginia, The American Legion, Inc., As Amended through April 8, 2015 - 7:00 PM, ARTICLE XI, The Corporation, Line 11, states "The Board of Directors will consist of seven (7) members-at-large to be elected at the regular election of Post 177 officers..." Line 29 further states, "In addition to the board of Directors named above, the Post Commander, if not elected member of the Board of Directors, will be an ex-officio member of the Board of Directors during his term as Post Commander.

Therefore, since the Corporate Board of Directors of the Corporate Board of Post 177 consists of seven (7) elected members, and since the ex-officio member does not count toward a quorum according to Robert's Rules of Order, the quorum for Corporate Board meetings and subsequently official voting on motions and/or on less formal initiatives shall be four (4) members.

Position: It is the intent of the Judge Advocate to read the following motion into the record during the Executive Committee Meeting (ECM) on March 2, 2016 and during the Regular Membership Meeting (RMM) on March 9, 2016: "I move that the following sentence be added to the current Post Constitution; ARTICLE XI, starting at line 22, in order to clear up a point of ambiguity on our Constitution: "A quorum for the purpose of an officially called or scheduled meeting of the Corporate Board of Post 177 shall be four (4) officially elected members of the Corporate Board as specified within this paragraph. No ex-officio, nor any other type of member shall be counted in determining this quorum." Further, it is the intent of the Judge Advocate to actually make the motion during the Regular Membership meeting on April 13, 2016.
